8. Period of bid validity

The bid validity shall be at least 120 calendar days from the day of its submission.

9. Terms and conditions of participation in the proceedings/ eligibility criteria

An economic operator, whose compliance with the following eligibility criteria has been confirmed based on the provided statements specified in this Invitation for Bid may participate in the proceedings. Non-fulfilment of any of the eligibility criteria shall result in rejection of the respective Bid.

1) Economic operators having personal and/or capital links with the Contracting Party are excluded from the proceedings. Capital or personal links mean any mutual connections between the Contracting Party or persons authorized to enter into obligations on behalf of the Contracting Party or persons performing - on behalf of the Contracting Party – activities associated with preparation and carrying out the proceedings to select the Supplier, and the Supplier, in particular:

- the participation in the company as a partner of a civil or other personal partnership;
- holding of at least 10% of stocks or shares;



- holding the function of a member of a supervisory or managing body, proxy, authorised representative,
- being joined in matrimony, related through kinship or direct affinity, secondary kinship or affinity up to the second degree, or linked through adoption, care or custody.

This criterion will be verified based on the Appendix 1 to this Invitation for Bid.

2) The Bidder shall have suitable human resources capable to perform the subject matter of the Contract and the relevant expertise and experience in the scope covered by the Contract. In particular, the Bidder:

- shall have documentary evidence confirming the experience in manufacturing spherical, pearlitic cast iron rolls for hot rolling.

This criterion will be verified based on the Appendix 4 to this Invitation for Bid. Bidder is also required to submit a reference list describing the due diligence of the aforementioned Supply of rolls.

10. Period of execution of the subject-matter of the Bid

The Supplier of Spherical, pearlitic cast iron rolls shall carry out the works in accordance with the material and financial schedule of the Contract.

The maximum period of delivery of all cast steel rolls shall be 140 days from delivery the contract.

11. Description of the subject-matter of the Invitation for Bid

The subject of the order will be delivery of spherical, pearlitic cast iron rolls, in the amount of 12 pieces for rolling a new profile.

Parameters and requirements for cast steels:

- 1) Material: spherical, pearlitic cast iron. Hardness 470- 490 HB (66-68 Shc)
- 2) As delivered conditions of the rolls: after stress relief annealing, and finally machined as per the drawing, which is in appendix 3.
- 3) Required Acceptance Certificate, Roll Quality Certificate.
- 4) Protected against corrosion and mechanical damage..
- 5) Free of hazardous and radioactive substances..
- 6) After casting, the roll to be ultrasound tested for internal defects and cracks..
- 7) The right to assert claims for hidden defects until the roll has achieved a dead diameter (- 75mm from the diameter of the originally machined roll).



8) Detailed roll specification - see Annex 2.

The Supplier shall deliver the rolls to Cognor SA Ferrostał Łabędy w Zawierciu in damage-free conditions. The transportation of the equipment is done with care, at the cost and risk of the Bidder.

The requirements to be met by trucks used to carry the rolls to the Contracting Party:

1) 1st method

- a) Truck with skip trailer adjustable to the width of roll barrel.
- b) Rolls to be secured by belts..
- c) Rolls to be unloaded by lifting using overhead crane.
- d) Tarpaulin removable from each side wall or roof.

2) 2nd method.

- a) Platform-type trailer equipped with suitable supporting racks to secure the rolls from displacement..

A driver hired to deliver the rolls to the Contracting Party shall be in possession of and use the following Personal Protective Equipment:

- 1) Helmet with strap under chin
- 2) Reflective vest
- 3) Steel toed safety shoes

b. The Bid with the highest score calculated as per the table above shall be considered the most competitive one.

c. In case of submitting a bid denominated in foreign currency, the value of such bid shall be converted into Polish zloty (PLN) at the average rate of exchange published by the National Bank of Poland (NBP) as on the day of bid evaluation in order to assure objective comparability of all bids.

d. When selecting the bid, the Contracting Party will follow the rules applicable to the EU's common market, in particular, the principle of: transparency and openness of the proceedings, protection of fair competition, free movement of capital, goods and services, and non-discrimination and equal treatment of all Suppliers on the market

e. All criteria for bid selection should be referred to in the bid. Should the Bidder omit one or more evaluation criteria his bid shall be granted zero score for the respective criterion (criteria).



14. Negotiations with the Bidders

The Contracting Party reserves the right to negotiate with all bidders on the same terms and conditions and with transparency of the proceedings. In such case the Bidders shall provide revised versions of the bids previously submitted.

15. Contract conclusion

The contract will be concluded in the form of a signed contract by both parties, the contract template was attached to this inquiry. The contract will be concluded immediately after selecting the supplier.

16. Special entitlements of the Contracting Party

- 1) The Contracting Party reserves the right to:
 - terminate the proceedings covered by the Invitation for Bid at any time until submission of the bids,
 - close the proceedings without selection of the Supplier,
 - cancel the proceedings both, before and after the selection of the best bid without giving a reason.
- 2) In the foregoing cases, the Supplier shall not be entitled to assert any compensatory claims against the Contracting Party.

17. Additional provisions

- 1) Partial or variant bids may not be submitted within the scope of Request for Quotation.
- 2) The Contracting Party, upon the assessment of the submitted bids, shall select the best bid; the selection shall be confirmed by the respective report.
- 3) If required by the submitted application for co-financing, the bids may be submitted to competent public authority for verification.

18. The Bid may be deemed valid if it contains:

- 1) full name and address of the Bidder, VAT-Reg. No. (NIP) and number of entry into the National Court Register (KRS) or into the Register of Entrepreneurs (EDG),
- 2) net and gross price for performance of supplies and services (the latter value shall comprise VAT).
- 3) date of preparation and validity of the Bid,
- 4) period of execution of the subject-matter of the Bid
- 5) terms and conditions of payment,

- 6) contact data of the person responsible for the Bid,
